THIRD LANE TRUCK LAW

or may not be aware of the "Third Truck Lane Law" that was proposed earlier this year in the legislature – Well, You may that got put to rest. Although did you know the Maine Turnpike Authority agreed to a 'no trucks in the third lane law' in order to acquire a needed permit for the widening? Wasn't made very public was it?

Below you will find more detailed information about this. One very, very important thing here is this - if you care about no trucks in the third lane on the Maine Turnpike - YOU NEED TO BE THERE, at the next MPDA General Meeting on May 3rd

Dan Paradee from the Maine Turnpike Authority will be there to answer your questions and hear your concerns on this very important issue. Turnout is expected to be heavy, with representatives from MMTA, Maine trucking companies, as well as other officials from various agencies. Elsewhere in this newsletter, you will find directions to the meeting location.

FACTS ABOUT THE PROPOSED RULE PROHIBITING TRUCKS FROM THE LEFTMOST LANE ON THE THREE LANE SECTION OF THE MAINE TURNPIKE

It is expected that the Maine Turnpike Authority and the Maine Department of Transportation will hold a public hearing during the Authority's regular monthly meeting on May 22 to consider a rule that would prohibit trucks from the leftmost lane on the three lane section of the Maine Turnpike. Here is a brief explanation of why this restriction is necessary to comply with the federal environmental permit granted for the Maine Turnpike Widening project.

- In order to obtain necessary environmental permits for the Turnpike Widening project from the U.S. Environmental Protection Agency, the Maine Turnpike Authority and the Maine Department of Transportation were required to perform an air quality analysis to determine the effect of the new third lane on the regional air emissions.
- The results of the air quality analysis indicated that emissions would worsen as a result of the Turnpike widening. To obtain the necessary federal environmental permits the Turnpike would have to offset these emission impacts.
- The Turnpike Authority conducted an exhaustive analysis to identify a list of all possible mitigation measures to offset the air quality impacts of the Widening. This list included:
 - The expansion and construction of new park

- and ride facilities
- The installation and operation of an extensive network of electronic highway message boards
- The installation and operation of a highway advisory radio station (1610 AM)
- The implementation of a fixed fare and electronic toll collection system (Transpass)
- Significant investments in transportation educational programs
- And the prohibition of trucks and buses from the leftmost lane on the three lane section of
- In the final analysis all of the above actions were required to generate enough air quality credits to obtain the necessary permits from the U.S. Department of Environmental Protection. The prohibition of trucks from the leftmost lane generated more than 25% of the credits needed, making it an essential part of the mitigation package.

The third lane was added for safety reasons, and now they want to restrict trucks from that lane causing congestion and unsafe conditions.

We have been there when the turnpike has needed us for safety committees and whatever support they may have needed – **but where is the Maine Turnpike Authority when we need them?**

Well it looks like spring has sprung and the grass has risen, I wonder where the flowers is. That was just a little poem from my childhood. It really is nice to see the temperature on the rise and the frost heaves going away. Just in time for another season of major road maintenance and construction. Well it's pretty hard to do any roadwork in this part of the country in the winter months.

Talking about spring and road construction leads me into this month's safe driving tip. You can probably guess what it will be about. That's right, safe driving in construction zones.

Lets look at some facts from the U.S. DOT and the Federal Highway Administration. Then lets look at some safe driving tips for construction zones.

- * Over the last 5 years the number of persons killed in motor vehicle crashes in work zones has gone from 717 in 1996 to a high of 1,093 in 2000.
- * In 2000, 1,093 fatalities resulted from motor vehicle crashes in work zones of which 264 resulted from large truck crashes.
- * In 2000, almost two times as many fatal work zone crashes occurred on weekdays compared to weekends.
- * In 2000, the percentage of <u>fatal work zone crashes</u> occurring on urban interstates was nearly twice the percentage of all <u>fatal crashes</u> occurring on urban interstates. (11% compared to 6%)
- * Over 40,000 people per year are injured as a result of motor vehicle crashes in work zones.

So why the increase in crashes and fatalities in work zones? SPEED, IMPATIENCE, TAILGATING, and INATTENTION are the most common reasons. Here are some tips.

- <u>SLOW DOWN</u> in construction zones. The lanes are narrow or reduced to single lanes quite often and may be offset or in a zigzag pattern.
- BE PATIENT There is no way you are going to make up for lost time because of a construction delay. **Continued/oupages***

be resolved to that fact.

- **DON'T TAILGATE** Trying to stay on the bumper of the vehicle in front of you to prevent someone else from getting in front of you is not worth the risk you take by tailgating the vehicle ahead of you. Your chances of not rear-ending the vehicle ahead of you in stop and go traffic are much less if you leave a gap.
- PAY ATTENTION In a construction zone with slowed or stop and go traffic is not the time to be fidgeting with your radio, cd or tape -player, cell phone, or anything else that might distract your attention from the traffic and conditions around you. Looking away from the road even for a few seconds can be time enough to cause a crash.
- <u>FINES</u> for speeding in construction zones in most states now are doubled. That can take the profit out of a trip real quickly not to mention costing you points on your driving record.
- When you know you are approaching a construction zone begin to prepare for the worst. Be prepared for slow moving construction vehicles and workers who may be in the road or crossing the road.
- When you see the signs that say a lane is closed ahead merge into the lane that will be open as soon as you can safely do so. Don't be the guy or gal who has to see how many more vehicles they can pass before you reach the barricades.
- Make allowances for other drivers who may be confused or may not know what lane to be in. Remember you are the professional driver and should be defensive in your driving habits and skills at all times.
- Be aware of vehicles hauling campers, vehicles hauling boats, motor homes, or other drivers who may not be completely familiar with the type of vehicle or combination they are driving.
- Finally try to stay in one lane and don't pass when driving in construction zones unless it is absolutely necessary.

Well that's it for this issue of *Behind the Wheel*.

Remember to be SAFE, COURTEOUS, and PROFES-SIONAL out there on the boulevard because you and I are representing the trucking industry and we want our industry to look good don't we.

If you pass me in the Macomber one stack MACK with the tinted sliding window in the back don't blow my doors off and for crying out loud say hello to the Gray Ghost.
