- There were 17 past State Champions in this year's Maine competition. Seven out of the eight State Champions this year are repeat winners while Rob Balfour wins his first State Championship. Rob follows in his dad's footsteps as Bob won State Championships in 1987 and 1988. Out of this year's Champions, **Randy DeVault**, Jeff Murdock, **Eric Foster**, Scott Crane, **Rob Fernald**, Hayri Berberoglu and **Warren Lewis** are past Champions. **Randy DeVault** becomes the first Maine driver to win four years in a row (a recent ATA rule change allows winners to continue but in different classes).
- **Randy DeVault** has now tied **Denis Litalien** and **Charlie Nadeau** for the record among Maine drivers for winning the most State Championships, all having done it 10 times. (Charlie retired last year and no longer competes and Denis finished second in the 4-Axle class this year.) Following close behind are **Fern Richard** with 9 wins (retired) and

- **Warren Lewis** with 7 wins.
- Maine has five past National Champions. Mark Corriveau of **Hannaford Trucking Co.** (2-time National Champion) has retired from competition, **Everett Macmaster**, who is ineligible to compete this year and **Randy DeVault** of Roadway Express, who is the State Champion in the Straight truck Class in this year's competition, are past Champions at the ATA National Truck Driving Championships. Also, **Warren Lewis** and **Rick Magnuson**, both of **Hannaford Trucking** and **Everett Macmaster** of FedEx Express are past National Champions at the U.S. Professional Truck Driving Championships.
- Next year's Maine State Truck Driving Championships will be held again in Bangor with the competition being held at **Dysart's** in Hermon and all the other activities again being held at the Bangor Motor Inn. Mark the date, May 17<sup>th</sup>, 2008, on your calendars.
- 2007 marked the 58th anniversary of the first Maine State Truck Driving Championships held in Maine. The first Championships were held at the old Portland Stadium (Fitzpatrick Stadium) in the grass on September 17, 1949 with only two classes competing: tractor semi-trailers and straight trucks. The Truck Roadeo, as it was then called, was put on by the Maine Truck Owners Association, the forerunner of today's Maine Motor Transport Association.
- **Clifford W. Perham, Inc./Shaw's Supermarkets** sponsored this year's 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Place Awards for the Championships.
- Over 100 people were involved in organizing, judging, competing and peripheral activities of this year's championships.
- There were 15 rookies this year. Rookies are drivers who have never competed in a State Championship. Ben Thompson of UPS Freight was named the Rookie of the Year at this year's competition. Maine Commercial Tire, Inc. sponsored this award.

- Thirteen companies had 3 or more drivers in the competition. UPS Freight, **Sysco of Northern New England** and FedEx Freight each entered 6 drivers while **Dysart's Transportation**, **Pottle's Transportation** and Con-Way Central Express each had 5 drivers. Along with those, **Hannaford Trucking**, FedEx Ground, Yellow Transportation and **Clifford W. Perham, Inc./Shaw's** each had four, making them all eligible for the Team Trophy. This award is sponsored by J.J. Keller & Associates.
- **Sysco of Northern New England** took the award this year after their drivers finished 1<sup>st</sup>, 2<sup>nd</sup>, 6<sup>th</sup> and 8<sup>th</sup> in their respective classes with an average score of 266. Those drivers included Hayri Berberoglu, Adrien Doyon, Bill Butland and John Dionne, respectively. JJ Keller & Associates sponsored the award.
- **Clifford W. Perham, Inc./Shaw's** took second place in the Team Award with an average score of 235.75 while FedEx Ground took third with an average of 234.5.
- MMTA used to invite the Vermont drivers to join Maine's drivers in this competition as Vermont does not hold its own competition. Since 2005 Vermont's drivers compete in New Hampshire to qualify for the Nationals.

### CHAMPIONS GET-TOGETHER

**Dave Littlefield** and **Cliff Gray** hosted a get-together for all the Champions on June 3rd at the MMTA office in Augusta. Drivers and spouses met and get to know each other and share some information about the national competition. Dave Littlefield and Denis Litalien will also host a practice session for the State Champions to sharpen up their competition skills. Maine drivers last year won the Team Award at the nationals that goes to the State with the highest average score and would like to repeat that feat. Anyone who wants to come and help with the practice should be at Emery-Waterhouse parking lot around 9:00am on Aug. 5.

**NATIONAL TRUCK DRIVING CHAMPIONSHIPS**

The ATA National Truck Driving Championships will be held August 21st through the 25th in Minneapolis, Minnesota.

Officials for the competition will begin laying out the course on Tuesday, August 21<sup>st</sup> while contestants are expected to be at registration at 11:00am on Wednesday, August 22nd at the Convention Center. It is recommended that attendees arrive in Minneapolis no later than Tuesday, to have time to settle in and be ready for Wednesday to take into consideration any delays that may occur. Points are deducted for not being on time. Spouses of contestants will also register on Wednesday.

The course review, written test and equipment selection will be held on Wednesday for the drivers while the driving, interviews, and pre-trip inspections will be held Thursday and Friday. The Truck Driving Championship finals will be held Saturday morning with the awards banquet to follow on Saturday evening.

The U.S. Professional Truck Driver Championships were cancelled last year after 5 years of accepting drivers who worked for companies that were not members of American Trucking Associations.

All Maine attendees usually meet for dinner on Wednesday evening as a group when attending the nationals.

**TRUCKERS FIND REST STOPS IN SHORT SUPPLY, JOURNAL SAYS**

Truckers around the country are having difficulty finding rest stops at which to park, and parking spots close to cities are especially hard to find, the Wall Street Journal reported on May 1.

In a front-page story in its Marketplace section, the Journal said that many truckers have taken to parking their rigs on highway shoulders once they reach their 11-hour driving limit - and sometimes are then ticketed for doing so.

Police sometimes let truckers parked on the sides of roads off with warnings, citing safety as their primary concern, the story said.

Some truckers can find places to park at large retail parking lots, such as Wal-Marts, but those depend on local management and don't usually have things like showers and bathrooms available, the Journal reported.

One truck-stop company, Pilot Travel Centers, said the number of truck stops is growing by 2% to 3% per year, but that it is hard to find places to expand, the paper said.

**DHS SETS \$11.6 MILLION FOR HIGHWAY WATCH PROGRAM**

The Department of Homeland Security said Thursday it has issued an \$11.6 million grant to the Highway Watch program it sponsors jointly with American Trucking Associations.

DHS said the Highway Watch grant will be used to recruit and train "truckers and other highway professionals to identify and report security and safety situations on our nation's roads."

It was part of a larger package of funding DHS' Infrastructure Protection Program, which will get \$445 million in security grants for the 2007 fiscal year.

"These grants will help to protect our nation's critical infrastructure from threats and hazards that could cause major loss of life, economic impact, and disruption of services," said DHS Deputy Secretary Michael Jackson.

**REPORT SHOWS DOWNTURN IN '06 LARGE-TRUCK CRASH FATALITIES**

Preliminary data released by the Department of Transportation show that fatalities from large truck crashes declined 3.7% last year compared with 2005.

DOT issued the preliminary report Friday, which showed fatalities from large-truck crashes fell to 5,018 last year, from 5,212 in 2005.

Overall traffic fatalities fell to 43,300 last year from 43,433 in 2005, DOT said.

The report also showed a decline in the fatality rate to 1.44 deaths per 100 million vehicle miles traveled, from 1.45 in 2005. DOT said the projections based on partial data and are likely to change when finalized.
