## Officer's Reports

### President's Message

My name is George Colby. I have been a member of MPDA since 1998 but only started attending meetings 2 1/2 years ago. Not many of you know me. I live in New Gloucester with my wife of 35 years, Cathy. We have 3 daughters and 1 son along with 3 sons-in-law, 1 daughter-in-law, 3 grandsons and 2 granddaughters.



I have been driving for 22 years, 9 years in construction, 1 year reefer OTR and 12 years as a tanker yanker.

My goal for MPDA is to be in-your-face visible to professional drivers and to the general public promoting the safety, courtesy and professionalism that MPDA was founded for. I also plan to work with MMTA and others to get heavy trucks out on the interstate where they belong and work toward a better flow of freight movement.

In one of my first official projects for MPDA I contacted an Auburn city councilor to discuss the possibility that Auburn might be installing a number of roundabouts on Route 4. He related to me that a study done by the Androscoggin Transportation Resource Center, which can be seen at [www.atrcmpo.org/public/](http://www.atrcmpo.org/public/), addressed this. He told me emphatically that it wouldn't happen. He also told me about using a laser sighting device (very expensive) to time the lights which he thought would be the most likely scenario to address the traffic problems. This would synchronize the lights so that in theory once you get a green light you can go the whole length of Center Street without stopping.

I have a challenge for you professional drivers. Today with the price of fuel, tolls and other costs, you must find ways to help your company be more effi-

cient. Do more than what is expected of you. Make an effort to help your dispatch. We all know that "dispatch" does some strange things, but we usually don't know what they are dealing with. When you get the respect of dispatch that you are trying to work with them, usually they will listen to you more closely. One of the most interesting things to me is the lack of communication between dispatch and drivers, shippers and receivers, and companies that interact with each other. On your level be creative and make better communication happen. Sometimes you will open mouth and insert foot, but keep on trying anyway.

That's my soapbox for this issue.

### Legislative Officer Report

In the December 13, 2007 issue of The Coastal Journal, U.S Rep Tom Allen expressed his concern that the "price of diesel fuel is threatening to put Maine's independent truckers out of business". Representative Allen is working on three fronts to help Maine's independent truckers to survive. Specifically,

Tom co-sponsored the Federal Price Gouging Prevention Act (HR 1252). This act will give the Federal Trade Commission the power to impose new civil penalties which would "make violators regret ever gouging a single Maine family".

Tom Allen is also pushing for the passage of H.R. 4066, which is known as the "Close the Enron Loop-hole" Act. When passed, this act will regulate speculators who are now driving up energy prices through off-market trading.

And Tom Allen is fighting for his Small Business Fuel Cost Relief Act, H.R. 2133. This bill would create a tax credit for the difference in today's fuel prices compared to the price on Labor Day 2004. For example, gasoline costs about \$3.16 a gallon today but only \$1.94 on Labor Day 2004. The passage of this bill would allow Maine's independent truckers to deduct the difference in price from their taxes. H.R. 2133 will also raise the IRS Standard Mileage Rate to 60 cents for vehicles used by small business owners.

On a personal note and a different topic, I have enjoyed serving as the Maine Professional Drivers Association Legislative Officer for the past two years. I highly recommend that all MPDA members get involved with this organization. The past and current leadership of MPDA have been both patient and professional in keeping this association a valuable tool for promoting professionalism within Maine's trucking community. When I decided to run for legislative officer I was told that my job would be made a lot easier because the MPDA officers do a good job keeping in touch via email. I found this to be very true and I am amazed at how much has been accomplished by MPDA's past and current leaders.

This has been a real learning experience for me that has strengthened my faith in American freedoms and democracy. Working together with fellow American workers to better the trucking industry is a rewarding experience and a worthwhile investment of a little bit of your free time.

### Ryder Buys Lily

**Ryder System** announced that it has bought the truck leasing business of Lily Transportation Corp., a northeast regional transportation services company based in Needham, Mass. The acquisition closed in

January, Ryder said. Terms were not released.

Lily Dedicated Logistics Systems, including its Dedicated Contract Carriage operations, will continue to be owned and operated by Lily, Ryder said.

Ryder will buy Lily's truck fleet, including about 1,560 full-service lease units and over 240 contract customers served by Lily from its 15 locations in the Northeast.

Ryder is ranked No. 5 on the Transport Topics 100 listing of U.S. and Canadian for-hire carriers.

### Maine Suspends Some Weight Restrictions Due to Fuel Prices

In January, Governor John Baldacci signed a bill to temporarily allow trucks hauling forest products to exceed state weight limits by 5% in hopes of helping them offset high fuel prices. Governor Baldacci stated that the administration is also working on legislation to ease taxes for truck drivers hauling forest products. The truck weight legislation took effect in January and expires April 1.

### New Driver Training Rules

Commercial driver licenses applicants would be required to complete classroom and behind-the-wheel training from an accredited program, under a proposed new federal rule announced in December.

Beginning three years after the effective date of a final rule, CDL or upgraded CDL applicants would be required to provide a valid certificate from an accredited truck driving program, the Federal Motor Carrier Safety Administration announced.

"This proposed rule will give truck drivers additional skills needed to keep our roads safe," FMCSA Administrator John Hill said in a statement. The rule would not affect current CDL holders.

The training curriculum includes CDL safety regulations, vehicle operation and safe operating practices, FMCSA said. For a "Class A" CDLs for tractor-trailer drivers, the rule would require a minimum of 76 hours of classroom instruction and 44 hours of behind-the-wheel training, for a total of 120 hours. For "Class B" CDLs (large "box" or van trucks) and "Class C" CDLs (hazardous materials or certain passenger-carrying vehicles), the proposed rule would require a minimum of 58 hours of classroom instruction and 32 hours behind-the-wheel training, for a total of 90 hours.

### Hours of Service Update

Safety advocates have again gone to court to try to block the Department of Transportation's rule on truck driver hours of service (HOS). In court documents filed with the U.S. Court of Appeals, lawyers for a coalition of groups, including Public Citizen and Parents Against Tired Truckers, asked the court to enforce an order striking down the HOS rule.

The groups, citing the risk of driver fatigue, have twice persuaded a federal court to reject implementation of the extended hours. DOT's Federal Motor Carrier Safety Administration (FMCSA) codified the rules largely as previously written, allowing drivers 11 hours behind the wheel daily and letting them reset their weekly limit after a 34-hour break.

Judges in the U.S. Court of Appeals for the District of Columbia denied Public Citizen's request which had sought to have the court force FMCSA to reissue its interim rule without those two provisions, on the grounds the agency had not allowed for proper levels of notice and comment from the public before retaining the controversial pieces of the rule.

In related news, FMCSA has extended the comment period for the rules that were just re-released as interim rules. The comment period closes on March 17 after which they will make their final ruling on the HOS rule.

### Turnpike News

#### York Toll Booth

The Maine Turnpike Authority has moved one step closer to getting started on building the new toll booths to replace the plaza in York that was built in 1969.

Four sites have been identified as possibilities for the new \$35 Million plaza. The sites are: Mile 8.7, 9.9, 11.3, and 13.2. The final site is expected to be selected within three months, construction to begin in the summer of 2009 with completion due in 2011.

With 50% of all Turnpike traffic and 80% of trucks using EZPass, the Turnpike Authority plans to include high speed EZPass lanes.

There has been some opposition by local residents who would like to see the booths further south. Turnpike officials say that located the booths south of Exit 7 would encourage people to take route 1 to avoid the toll, creating more traffic in the already congested

area.

New Hampshire has posted new speed limit signs at the Hampton Toll Booth on I-95. The speed through those booths is 10 MPH.

### Truck Fatalities Fall to Record Low

Three of the primary measures of large truck safety fell to record lows in 2006 reports the American Trucking Associations. The 2006 fatal crash rate for large trucks was 1.93 fatal crashes per 100 million vehicle-miles-traveled, lower than the previous record low of 1.97, set in 2002, ATA said, citing Department of Transportation figures.

The large truck-involvement rate fell to 2.12 per 100 million vehicle miles traveled, down from 2.21 a year earlier, and the fatality rate declined to 2.24, down from 2.34 in 2005, ATA says.

Transport Topics reported in December that overall truck-related fatality rate was 2.24 deaths per 100 million miles driven in 2006, down from 2005's rate of 2.35 and the lowest rate of fatalities per mile since DOT began tracking the statistics in 1975. TT also reported that the number of large-truck crashes in which someone was killed fell to 1.94 per 100 million miles in 2006 — down from 2.04 the previous year and also the lowest rate since 1975.

### Driving School Scam

It has been reported to ATA that in recent weeks scam artists' are targeting truck driving schools and motor carriers with student training programs. The scam artist initially presents himself as a recruiter for a motor carrier and is extremely knowledgeable of the industry and carrier.

The schools have been forwarding a list of students and graduates and their personal information. The scam artist in turn makes direct contact with the student, hires them as a driver and convinces them to send money for a deposit for training costs. The scam artist will also identify himself as the Recruiting Department Supervisor for a motor carrier and talk with other family members, asking them to wire their fam-

ily member money. A number of schools and motor carriers have been approached in the last few days. If this happens to you, please contact the appropriate law enforcement.

## Trucking Carried More Than 10 Billion Tons of Freight in '06

The U.S. trucking industry hauled more goods than ever before in 2006 reports the American Trucking Associations. American Trucking Trends 2007-2008 reported that the trucking industry hauled 69% of all U.S. freight volume in 2006. That equates to an all-time high of 10.7 billion tons and \$645.6 billion in revenue, representing 83.8% of the nation's freight bill, the trucking group says.

"Americans should understand that their national economy is directly linked to freight transportation," ATA President Bill Graves said in a statement. "Trucking is the driving force behind our great economy." American Trucking Trends, an annual report produced by ATA, reported that more than 26 million trucks of all classes played a part in reaching the tonnage milestone. Of those, 2.9 million were typical Class 8 trucks operated by more than 750,000 interstate motor carriers.

## Toll Increases

Many states are looking at using tolls to alleviate their shortfalls in funding for highway projects. Pennsylvania is even preparing to add tolls to I-80 to help fund their highway budget. If this proposal goes through, it would cost truckers \$83 to run the length of I-80. New Hampshire is also proposing to put tolls on its planned bridge being considered in Nashua.

Massachusetts has raised tolls on all their toll roads and bridges. Tolls rose in New York by 10% in January. New York Thruway Authority board members are also proposing additional 5% increases for 2009 and 2010, and \$4 to \$8 increases for E-ZPass annual permits. Maine tolls are also scheduled to increase in 2010. New Jersey is planning to increase their tolls up to what could amount to 800% increases by 2020. Tolls are also increasing this year in a lot of other states.

Add this to the increase in fuel costs and we can all see how tough it is on truckers to keep up with all the additional costs, not to mention the inflationary increases in all other expenses to keep those wheels

turning.

Come to the MPDA meetings and discuss these and other topics. As a group we have a much larger voice that we do as individuals. And while we may not be able to change all these things for the better, we can at least share information and find solace in making the proper officials aware of how these costs affect those of us who have to move the goods of the nation.
