Message from the President

Greetings:

Elsewhere in this newsletter you will find the results of the recent election. I would like to welcome all the officers that will be taking office in January.

*July 1, 2013 there were some huge changes for drivers, two of the most egregious changes were the 34 hour restart requiring two consecutive days of 1:00AM to 5:00AM off duty and the required half hour break. This change has wreaked havoc on the trucking industry. The ATA, OOIDA and others took FMCSA the court but the court sided with FMCSA. FMCSA said it was a good rule, even though they have not completed the proper study to see if this would actually increase safety of truck drivers and the motoring public. So on October 31, 2013 **Richard Hanna** (R-NY) along with **Tom Rice** (R-SC), and **Mike Michaud** (D-ME) introduced HR 3413 also known as the **TRUE Safety Act** that would return the HOS to pre July 1, 2013. This bill now has 40 cosponsors. Here are 2 places to go for more information.*

ATA BOARD MAKES CHANGES TO NTDC

At their October 9th meeting, the Maine Motor Transport Association (MMTA) Board of Directors adopted a resolution supporting a more inclusive policy when it comes to non-ATA members competing at the National Truck Driving Championships (NTDC). We are pleased to report that the American Trucking Associations (ATA) Board has unanimously voted in favor of the resolution (language below) amending the requirements for the NTDC to include all competitors who are members of a state trucking association and that they will be afforded full and equal recognition.

Thanks go to Maine's State VP representatives to the ATA – Barry Pottle (at-large member) and Chelsea Pottle – for carrying our message along with other states who supported the change. Our hope is that this may encourage additional participation at future TDC events!

ATA Board Resolution:

RESOLVED, that in order to encourage and incentivize an increase in the number of drivers who strive to drive accident-free, eligibility to compete in the National Truck Driving Championships and National Step Van Driving Championships, and receive related recognition and awards during the competitions, shall be extended to all State Truck Driving Championships winners who are employed by or contracted to a motor carrier member of an ATA-affiliated state trucking association and meet all other applicable eligibility requirements.

ATA's National Truck Driving Championships (NTDC) and National Step Van Driving Championships will be held August 9-13 in Pittsburgh.

Maine Trucking for Kids Convoy

2013 marked the 24th year the Maine Professional Drivers Association has hosted or co-hosted the Maine Trucking for Kids Convoy. During that span the event has raised over \$185,000 for local charities involving kids, including donating over \$100,000 to Camp Sunshine since joining forces with the Lions Clubs in 1999. FMCSA to change violation challenge process in PSP, CSA

The way FMCSA reports driver violations to the mega database that feeds data to the Pre-Employment Screening Program and Comprehensive, Safety, Accountability enforcement program is changing.

The Federal Motor Carrier Safety Administration will publish a notice on Monday, Dec. 2, that outlines the way violations will be reported to the Motor Carrier Management Information System, or MCMIS.

That database supplies the roadside inspection and violation data to the PSP and the CSA program. The PSP program provides listings of all driver roadside inspection violations and crash reports to prospective employers. CSA scores and weights violations to determine motor carrier and driver compliance in various categories. The motor carrier rankings are public, but the driver ratings are used internally at FMCSA for enforcement only.

Drivers and motor carriers currently have the option to contest violation data in MCMIS. The challenges, called DataQ, are submitted to FMCSA and routed back to the originating law enforcement agency.

Before the changes outlined in the notice, if a driver were to be found not guilty or have a citation dismissed in court, there was no policy in place to have the corresponding violation removed from MCMIS. That led to inconsistencies in how challenges were handled state to state.

With the announced changes, challenged violations that have a corresponding citation that is either dismissed or given a “not guilty” verdict will have the challenged violation removed.

Citations that are dismissed by a court but have fines or court fees assessed will be reported as convictions to the system.

If the court convicts the driver of a charge different from the original citation, the original corresponding violation will remain in MCMIS. There will be a note added to the violation that the legal challenge “Resulted in conviction of a different charge.” In the PSP program, the violation will also remain with a similar notation of being

convicted of a different charge. For the purposes of CSA, the severity weight, or points, associated with the violation will be reduced to the lowest value of either the original violation or the newly convicted corresponding violation.

The notice says the changes will only apply to inspections on or after the implementation date of the policy.

After Monday, the public will have 30 days to comment on the prospective application of the changes. All comments should include Docket No. FMCSA-2013-0457. Comments can be submitted:

DOT Proposes to Reduce Trucking Paperwork

In a USA Today report on August 1, Transportation Secretary Anthony Foxx proposed to reduce trucking paperwork to save the industry \$1.7 billion a year. The paperwork deals with inspection reports required before and after every trip a commercial truck makes, called Driver Vehicle Inspection Reports. The inspections on 4 million vehicles nationwide cover 20 items to check, in case anything needs repair. Under Foxx's proposed rule, truckers would be required to file only reports that detail defects, which are found in only 5% of inspections.

Trucker Trivia

- More than 80 percent of U.S. communities depend solely on trucking for delivery of their goods and commodities.
- One in every 19 Americans is employed by the trucking industry, including 3.1 million professional drivers.
- Trucks have overall crash rates less than half of other vehicles.
- Professional truckers drove more than 397.8 billion miles in 2010, more than double 25 years ago. Most individual long-haul drivers average 100,000 to 110,000 miles a year.
- The average daily run for an over-the-road driver is nearly 500 miles.
- The trucking industry paid \$36.5 billion in federal and state highway taxes in 2011 when it represented 9.8 percent of the vehicles on the road.
- The trucking industry consumed 52.8 billion gallons of diesel fuel and gasoline in 2012.

Self Certification Deadline Approaching

On January 30, 2012 the Federal Motor Carrier Safety Administration began requiring CDL holders to identify if they conduct intrastate or interstate commerce and if they hold non-excepted or excepted status. Most truckers are classified under non-excepted interstate commerce and must furnish a current medical examiner's certificate to state agencies.

Those who do not need to have a license renewal, upgrade or transfer during the two-year implementation process still must self-certify and provide the certificate, often called a DOT card, by the 2014 deadline.

State agencies who do not receive self-certification, medical certificates and any required variance from CDL-Holders by the compliance deadline must notify drivers that they are no longer medically certified in non-excepted interstate commerce. State officials will remove all CDL privileges from their licenses.

NHTSA Data Confirms Traffic Fatalities Increased In 2012

On November 14 the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) today released the 2012 Fatality Analysis Reporting System (FARS) data indicating that highway deaths increased to 33,561 in 2012, which is 1,082 more fatalities than in 2011. The majority of the increase in deaths, 72 percent, occurred in the first quarter of the year. Most of those involved were motorcyclists and pedestrians. Highway deaths over the past 5 years remain at historic lows.

Diverging Diamond Intersection

Want to see the latest in highway construction ideas? Have you ever heard of a Diverging Diamond Intersection? This is a new type of interchange being tested in Missouri and has been used in France. The FHWA is recommending innovative intersection designs to increase capacity, decrease congestion, and minimize the cost of new infrastructure.

This new type of intersection does not have any left turns that must clear opposing traffic so the design can improve traffic movement with more green time. It will move traffic faster, reduce congestion, and increase safety.
